Vocational Education and Training Act, 2008

Regulations under the National Vocational Training Act, 1994 Government Notice 234 of 1996

Published in Government Gazette 1399 on 6 September 1996

Commenced on 1 September 1996

[Note: The version of this legislation as at 15 November 2017 was revised and consolidated by the Legal Assistance Centre and the Government of the Republic of Namibia. All subsequent amendments have been researched and applied by Laws.Africa for NamibLII.]

These regulations were originally made in terms of the National Vocational Training Act 18 of 1994, which was repealed by the Vocational Education and Training Act 1 of 2008. Pursuant to section 49(6) of the Vocational Education and Training Act 1 of 2008, the regulations are deemed to have been made under that Act.

1. Interpretation

In these regulations, and in the forms in the Annexure, unless the context otherwise indicates, any word or expression to which a meaning has been assigned in the National Vocational Training Act, 1994, shall have the same meaning and-

"the Act" means the said National Vocational Training Act, 1994 (Act 18 of 1994).

[The National Vocational Training Act <u>18 of 1994</u> has been replaced by the Vocational Education and Training Act <u>1 of 2008</u>.]

2. Contracts of apprenticeship

A contract of apprenticeship contemplated in section 19 of the Act shall be in the form of Form 1.

3. Transfer of contract of apprenticeship

The transfer of a contract of apprenticeship under section 20 of the Act shall be effected in the form of Form 2.

4. Termination of contract of apprenticeship

The notification of the termination of a contract of apprenticeship-

- (a) by mutual understanding as contemplated in section 22 of the Act;
- (b) during probation as contemplated in section 23 of the Act, shall be in the form of Form 3 and Form 4, respectively.

5. Records of apprentices

The records to be kept of an apprentice in terms of section 25 of the Act shall be in the form of Form 5.

6. Particulars of supervisors

The particulars of supervisors contemplated in paragraphs (a) and (b) of section 28(1) of the Act shall be submitted in the form of Form 6.

7. Repeal

The regulations made under the Apprenticeship Ordinance, 1938 (Ordinance 12 of 1938), are hereby repealed.
