ORDINANCE, 1974: PROMULGATION OF

Dit behaag die Administrateur om sy goedkeuring te heg, ooreenkomsdig artikel 27 van die Wet op die Konstitusie van Suidwes-Afrika, 1968 (Wet 39 van 1968) aan die volgende Ordonnansie wat hierby vir algemene inligting gepubliseer word ooreenkomsdig artikel 29 van gemelde Wet.

**ACCOMMODATION ESTABLISHMENTS AND
TOURISM AMENDMENT ORDINANCE.**

(Assented to 10 December 1974.)

(Afrikaans text signed by the Administrator.)

(Date of commencement 1 August 1974.)

ORDINANCE

To amend the Accommodation Establishments and Tourism Ordinance, 1973, so as to provide for the establishment, erection, equipment, take-over, running and letting of accommodation establishments; and to provide for matters incidental thereto.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, as follows:-

1. The following section is hereby inserted in the Accommodation Establishments and Tourism Ordinance, 1973 (Ordinance 20 of 1973) after section 47:

*Insertion of section 47A in
Ordinance 20 of 1973.*

"Executive Committee
may establish, take over,
run, let and sell accommoda-
tion establishments.

47A. The Executive Committee may at any time if it considers it necessary or desirable for the promotion of tourism or in the public interest -

- (a) establish, erect and equip an accommodation establishment;
- (b) take over any existing accommodation establishment

and may run, let or sell any accommodation establishment which it has so established, erected and equipped or taken over.”

2. This Ordinance shall be called the Accommodation Establishments and Tourism Amendment Ordinance, 1974, and shall be deemed to have come into operation on the first day of August, 1974.
