#### INCREASE OF RATE OF INTEREST ON CERTAIN ARREAR PAYMENTS ON LOANS GRANTED UNDER THE AGRICULTURAL CREDIT ACT, 1966

Under the powers vested in me by section 23(3)(c)(i), of the Agricultural Bank Amendment Act, 1991 (Act 27 of 1991), and with the concurrence of the Minister of Agriculture, Water and Rural Development, I hereby amend the terms and conditions of all loans that have been granted in terms of the Agricultural Credit Act, 1966 (Act 28 of 1966) before the Agricultural Bank Amendment Act, 1991, came into operation on 23 December 1991, by increasing the rate of interest chargeable on arrear amounts in respect of capital instalments or interest payments on such loans to a rate of 12% per annum, as from 1 September 1993.
