NOTIFICATION OF CANDIDATES, POLLING DAY AND POLLING STATIONS: BY-ELECTION FOR MEMBER OF ERONGO REGIONAL COUNCIL IN RESPECT OF SWAKOPMUND CONSTITUENCY: ELECTORAL ACT, 2014

In terms of section 82(5) of the Electoral Act, 2014 (Act No. 5 of 2014), it is made known that -

- (a) the persons whose names, sex, voter registration numbers and residential addresses appear in Column 1 of the Schedule have in terms of section 82(1) of that Act been declared to be duly nominated candidates for election as members of Erongo Regional Council in respect of Swakopmund Constituency;
- (b) a poll must take place on 29 May 2015 from 07h00 until 21h00 for the election of a member of the Erongo Regional Council in respect of Swakopmund Constituency; and
- (c) in terms of section 89 of that Act, polling stations for the election referred to in paragraph (b) have been established in Swakopmund Constituency at the places mentioned in Column 2 of the Schedule and in terms of section 89(5) of that Act mobile stations have been provided, in respect of that election at the places mentioned in Column 2 of the Schedule and the places to be visited in terms of section 89(7) by a mobile polling station during the polling period

and the time at which it must visit such places must be made known by the returning officer in a manner he or she considers fit and practicable.
