NOTIFICATION OF CANDIDATES, POLLING DAY AND POLLING STATIONS: BY-ELECTION FOR MEMBER OF OTJOZONDJUPA REGIONAL COUNCIL IN RESPECT OF OTJIWARONGO CONSTITUENCY: ELECTORAL ACT, 2014

In terms of subsection (5)(b) of section 82 of the Electoral Act, 2014 (Act No. 5 of 2014), it is made known that -

- (a) a poll takes place on 9 July 2015 from 07h00 until 21h00 for the election of a member of the Otjozondjupa Regional Council in respect of the Otjiwarongo Constituency;
- (b) the persons whose names, sex, voter registration numbers and residential addresses appear in Column 1 of the Schedule have, in terms of subsection (1) of that section, been declared to be duly nominated in respect of the by-election of a member referred to in paragraph (a), with an indication of the political party by whom each candidate was nominated; and
- (c) in terms of section 89 of that Act polling stations have been established at the places mentioned in Column 2 in respect of the election referred to in paragraph (a), and the places to be visited by the mobile polling stations, provided under section 89(5) of that Act, during the polling period and the times at which the mobile polling stations visits the places is to be made known by a returning officer in a manner that he or she thinks fit and practical.
