DETERMINATION OF DATE AND PLACE FOR SUBMISSION OF NOMINATIONS OF CANDIDATES AND POLLING DAY: BY-ELECTION FOR A MEMBER OF REGIONAL COUNCIL OF OTJOZONDJUPA: OTAVI CONSTITUENCY: OTJOZONDJUPA REGION: ELECTORAL ACT, 2014

Under the powers vested in me by section 64(1) of the Electoral Act, 2014 (Act No. 5 of 2014), read with section 80 of that Act, I, on the recommendation of the Electoral Commission of Namibia, make known that in respect of the by-election for a member of the Regional Council of Otjozondjupa, in respect of Otavi Constituency in the Otjozondjupa Region, I determine -

3 August 2015 as the date on which submissions of nominations of candidates for the election (a) of a member of the Regional Council of Otjozondjupa, in respect of Otavi Constituency must take place;

- (b) that the place for the submission of the nominations referred to in paragraph (a) is the Otavi Constituency office, Otjozondjupa Region during the hours 09h00 until 11h00; and
