PUBLICATION OF RESULTS AND PARTICULARS IN RESPECT OF OTJIWARONGO CONSTITUENCY BY-ELECTION: OTJOZONDJUPA REGIONAL COUNCIL: OTJOZONDJUPA REGION: ELECTORAL ACT, 2014

In terms of section 113(1) of the Electoral Act, 2014 (Act No. 5 of 2014), I publish the results and particulars of the announcement made and transmitted to the Commission in terms of section 111 of that Act in respect of the Otjiwarongo Constituency by-election for the election of a member of the Otjozondjupa Regional Council held on 9 July 2015, set out in the Schedule as follows:

- (a) column 1 indicates the total number of votes counted in the election;
- (b) column 2 indicates the number of votes recorded for each candidate;
- (c) column 3 indicates the names of the candidates as duly nominated for election under section 80 of that Act and the political party which nominated the candidate; and
- (d) column 4 indicates the name of the candidate declared as duly elected member of the Erongo Regional Council, under section 111(2)(b) of that Act with effect from 9 July 2015.
