In terms of subsection (1) of section 64 of the Electoral Act, 2014 (Act No. 5 of 2014), I make known that, on the recommendation of the Electoral Commission, I have under the powers vested in me by paragraph (a)(i) of that subsection determined -

- (a) for the election of a President, pursuant to Article 28 of the Namibian Constitution, read with sections 63(1)(a)(i), 74 and 75(1) of that Act, 18 October 2019 as the date on which the submission of nominations of candidates for election to the office of the President must take place at a public sitting to be held by the Chairperson of the Electoral Commission at Elections House, 67-71 Van Rhijn Street, Windhoek-North, from 09h00 until 11h00; and
- (b) for the election of members of the National Assembly, pursuant to Article 46 of the Namibian Constitution, read with sections 63(1)(b)(i) and 77(1) of that Act, 18 October 2019 as the last day on which political parties that intend to participate in the election for members of the National Assembly must, not later than 11h00 on that day, submit a written list of candidates nominated with a view to the filling of any seats in the National Assembly to which those political parties may become entitled, to the Electoral Commission at the Office of the Chief Electoral and Referenda Officer, Elections House, 67-71 Van Rhijn Street, Windhoek-North.
