## ACCOMMODATION ESTABLISHMENTS AND TOURISM AMENDMENT ORDINANCE, 1973.

(Assented to 29 November 1973.)
(English text signed by the Administrator.)
(Date of commencement 30 November 1973.)

#### **ORDINANCE**

To amend the Accommodation Establishments and Tourism Ordinance, 1973, in regard to definitions; the guest register to be kept; the establishment of tourist recreation areas and the objects of tourist recreation areas; and to provide for incidental matters.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:-

Amendment of section 1 of Ordinance 20 of 1973.

- 1. Section 1 of the Accommodation Establishments and Tourism Ordinance, 1973 (Ordinance 20 of 1973) hereinafter referred to as the principal Ordinance is hereby amended by the substitution for the definition of "tourist recreation area" of the following definition:
  - "tourist recreation area" means any area declared a tourist recreation area under section 48.".

Amendment of section 41 of Ordinance 20 of 1973.

- 2. Section 41 of the principal Ordinance is hereby amended by the substitution for subsection (1) of the following subsection:
  - "(1) The manager of an establishment shall keep, or cause to be kept, a guest register in the form approved by the Executive Committee and shall, on the arrival of any guest, enter the prescribed particulars in respect of such guest in such register, or cause such particulars to be entered in such register.".

Amendment of section 48 of Ordinance 20 of 1973.

- 3. Section 48 of the principal Ordinance is hereby amended -
  - (a) by the deletion of subsection (1); and
  - (b) by the substitution for paragraph (a) of subsection(2) of the following paragraph:
    - "(a) The Executive Committee may declare any area a tourist recreation area and assign a name to it.".

## ACCOMMODATION ESTABLISHMENTS AND TOURISM AMENDMENT ORDINANCE, 1973.

Substitution of section 50 of Ordinance 20 of 1973. 4. The following section is hereby substituted for section 50 of the principal Ordinance:

"Objects of tourist recreation areas. 50. An area shall be declared a tourist recreation area for the orderly development thereof, for the preservation therein of the environment and in the interest of and for the benefit and enjoyment of the inhabitants of the Territory and other visitors to the tourist recreation area.".

Repeal of Schedule 1 to Ordinance 20 of 1973. 5. Schedule 1 to the principal Ordinance is hereby repealed.

Short title.

6. This Ordinance shall be called the Accommodation Establishments and Tourism Amendment Ordinance, 1973.
