NOMINATION OF CANDIDATES FOR THE ELECTION OF MEMBERS OF THE COUNCIL

Notice is hereby given in terms of regulation 3 of the Regulations relating to Veterinary and Para-Veterinary Professions promulgated by Government Notice No. AG 76 in Official Gazette 5042 of 17 May 1985, that I await nominations of candidates for the election of two (2) members of the South West Africa Veterinary Council referred to in section 5(1)(b) and (c) of the Veterinary and Para-Veterinary Proclamation, 1984 (Proclamation AG. 14 of 1984). The nomination day shall be the 28th day after date thereof.

REMARKS:

The election arises from the expiration of the periods of office of the Council of Drs. H.H.P.A. Schneider and R.H. Hassel on 31 July 1993. Nominations are therefore awaited for the filling of the two (2) vacancies which would otherwise exist on the Council as from 1 August 1993. The said members are eligible for re-election and may be nominated if they are willing to serve on the Council for a further term.

Each enfranchised voter is entitled to nominate two (2) candidates. Nomination of candidates shall be in the form set out in Annexure A of the said Regulations and shall be lodged with me before 16:00 on nomination day. A separate form is to be used for the nomination of each candidate. Each such form has to be duly completed and shall be signed by both the person who is nominated as a candidate and the two persons by whom he is nominated. For the convenience of enfranchised voters forms are also obtainable from me.
