APPLICATION AND PROPOSAL THAT A PORTION OF FARM ROAD 1769 BE CLOSED: DISTRICT OF MARIENTAL: HARDAP REGION

It is hereby made known -

- a) In terms of section 16(3) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that application has been made to the Chairperson of the Roads Board of Hardap South that a portion of farm road 1769 described in Schedule 1 and shown on sketch-map P2004 by the symbols A-B-C be closed; and
- b) In terms of section 20(1) of the said Ordinance the Permanent Secretary: Works, Transport and Communication proposes that, in the district of Mariental, the portion of farm road 1769 described in Schedule II and shown on sketch-map P2004 by the symbols C-D be closed.

A copy of this notice and the said sketch-map on which the road to which the application refers and other proclaimed, minor and private roads in the area are shown, shall for the full period of 30 days mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Roads Superintendent, Mariental, during normal office hours.
