# NOTICE FOR ELECTION OF MEMBERS: NURSING PROFESSIONS ACT, 1993 (ACT 30 OF 1993)

Notice is hereby given for general information that an election of 9 members of the Nursing Board, to serve during the period 1 February 1998 to 31 January 2001, is to be held.

1. Every registered nurse and registered midwife resident in Namibia shall be eligible for nomination. Each candidate shall be nominated on a separate nomination paper in the form of Annexure C to the regulations and attached hereto. Any person entitled to vote in terms of the regulations may sign the nomination paper of any number of candidates not exceeding the number to be elected. Nomination forms will be supplied on request to any person entitled to vote in terms of these regulations. Each nomination shall state the full names of the persons nominated and shall be signed by two persons who

are registered nurses, registered midwives, enrolled nurses, enrolled midwives or enrolled nursing auxiliaries, as the case may be, who shall be Namibian citizens or have been lawfully admitted to Namibia for permanent residence therein, and resident in Namibia.

- 2. Each person who signs a nomination shall also sign the declaration set out in Annexure D to the regulations and attached hereto.
- 3. The person nominated shall sign the consent to nomination set out in Annexure E to the regulations and attached hereto. If the person nominated is unable to sign the nomination form he or she may inform the returning officer by letter, fax or telegram of his or her consent to be nominated. Each candidate shall simultaneously with the lodging of a nomination or not later than the date and time specified in paragraph 4 below, lodge with the returning officer -
  - (a) an amount of N\$20;
  - (b) written proof of Namibian citizenship or permanent residence in Namibia, to the satisfaction of the returning officer; and
  - (c) the consent to nomination concerned.
- 4. Every nomination form shall reach the undersigned at the address given below not later than 31 July 1997 at 16h00.
- 5. Every nomination form in respect of which any of these provisions has not been complied with or which is not received by the aforesaid date at the address given below shall be invalid.
- 6. The applicable Annexures are obtainable from the returning officer.
