PROPOSED CIVIL AVIATION REGULATIONS:

PART 65 - PERSONNEL : AIR TRAFFIC SERVICE

PERSONNEL LICENSING

The Ministry of Works, Transport and Communication recently initiated the project to update the current Namibian aviation legislation. There are two main reasons for updating the aviation legislation, namely, the current legislation does not adequately reflect the policies of Namibia for the aviation sector and does not reflect recent developments within SADC. The project further aims to enhance the safety of civil

aviation by ensuring that the Namibian legislation complies with the minimum standards prescribed by the International Civil Aviation Organization.

Part of the short-term legislative reform involves the updating of the regulations made under the Aviation Act, 1962 (Act 74 of 1962).

Due to the nature and extensive range of subjects which need to be regulated, this part of the project will be executed in phases and regulations will be published accordingly. The proposed structure of the Civil Aviation Regulations is set out in Schedule 1.

All the definitions for the proposed civil aviation regulations will be contained and published in Part 1. The definitions for each Part will however be published with each set of proposed regulations, to facilitate the interpretation thereof. The definitions associated with the proposed regulations on air traffic service personnel licensing are set out in Schedule 2.

The Director: Civil Aviation invites all interested parties to comment on the proposed structure of the Civil Aviation Regulations, the proposed definitions associated with the proposed regulations, as well as the proposed regulations on Air Traffic Service Personnel Licensing set out in Schedule 3. The proposed regulations represent Part 65 of the proposed structure.

The proposed regulations on Air Traffic Service Personnel Licensing make provision for certain information to be contained in a document called Document NA-CATS-ATSPL. The compilation of the document does not form part of this project, but it is envisaged as a document that will contain all the technical standards regarding air traffic service personnel licensing.

SCHEDULE 2

Definitions

In these regulations, unless the context otherwise indicates -

"aerodrome control service" means an air traffic control service for aerodrome traffic;

"aerodrome traffic" means all traffic on the manoeuvring area of an aerodrome and all aircraft in, entering or leaving an aerodrome traffic circuit;

"air traffic" means all aircraft in flight or operating on the manoeuvring area of an aerodrome;

"air traffic controller" means the holder of a valid air traffic service licence and rating to provide an air traffic control service;

"air traffic control service" means a service provided for the purpose of -

- (a) preventing collisions -
 - (i) between aircraft; and
 - (ii) on the manoeuvring area between aircraft and obstructions; and
- (b) expediting and maintaining an orderly flow of air traffic;

*

"air traffic service" means an aerodrome control service, an approach control service, an area control service, a flight information service, an air traffic advisory service, an alerting service or other service designated by the Director;

"air traffic service assistant" means the holder of an air traffic service licence and rating who provides -

- (a) assistance services to an air traffic controller; or
- (b) coordination services, clearance delivery services, flight information services or aerodrome flight information services;

"air traffic service inspector" means an air traffic service inspector designated in terms of section 5(4)(a) of the Act;

"air traffic service unit" means a unit providing an air traffic service;

"approach control service" means an air traffic control service for arriving or departing controlled flights;

"appropriate authority" -

i,

- (a) means any institution, body or person in a State or territory which, on behalf of that State or territory carries out the provisions of the Convention; or
- (b) if such Convention does not apply to a State or territory, means the institution, body or person in that State or territory which on behalf of the State or territory, performs the functions which are

performed by an institution, body or person contemplated in paragraph (a), and which is recognised as such by the Director;

"area control service" means an air traffic control service for controlled flights in control areas;

"break" means a period not exceeding 60 minutes within the period of operational duty, during which an air traffic controller is released from all duties;

"controlled flight" means any flight which is subject to an air traffic control clearance;

"Document NA-CATS-ATSPL" means a document on the Namibian Civil Aviation Technical Standards relating to Air Traffic Service Personnel Licensing, which is published by the Director in terms of the Act;

"manoeuvring area" means the area of an aerodrome which is used for the take-off, landing and taxiing of aircraft, excluding an apron;

"night duty" means a period of not less than 4 hours between 20h00 and 06h00 of the next day;

"period of operational duty" means the period during which an air traffic controller is actually exercising the privileges of the air traffic service licence;

"rating" means a qualification entered on or associated with a licence and forming part thereof;

"resident of Namibia" means a person who has his or her ordinary residence in Namibia and who is a Namibian citizen or is in possession of a permit for permanent residence

in Namibia issued in terms of the Immigration Control Act, 1993 (Act 7 of 1993);

"shift" means the period between the actual commencement and the actual end of a period of duty during which an air traffic controller exercises, or may be called upon to exercise, the privileges of the rating at the air traffic service unit for which such rating is validated, and includes breaks and time spent on other duties including training, aerodrome inspection, administration, flight information service and any extension of duty;

"shift cycle" means a consecutive 28 day period;

"the Act" means the Aviation Act, 1962 (Act 74 of 1962);

"valid" when used in connection with a licence or rating issued, validated, revalidated or renewed under these regulations, means that all the requirements applicable to such licence or rating, as prescribed by these regulations, have been complied with;

"validation" means an authorisation entered on a licence and forming part thereof, to exercise a specific rating at a specific air traffic service unit, containing special conditions, privileges or limitations pertaining to such rating;

"validation examiner" means an official validation examiner appointed by the Director or a validation examiner who has been designated in terms of the provisions of regulation 65.01.9.

SUBPART 1

GENERAL

Applicability

65.01.1 This Part shall apply to -

- (a) the issuing of air traffic service licences, ratings, validations and certificates for Namibian air traffic service personnel, the privileges and limitations of such licences, ratings, validations and certificates, and matters related thereto; and
- (b) the conversion of foreign air traffic service licences and ratings and the privileges and limitations of such conversions.

Authority to provide air traffic service

- **65.01.2** (1) No person shall provide an air traffic service within any airspace in Namibia, unless such person holds a valid air traffic service licence and rating complying with the requirements in this Part and appropriate to the duties being performed.
- (2) The holder of an air traffic service licence shall not exercise privileges other than the privileges granted by the licence and the appropriate valid rating held by such holder.
 - (3) The provisions of subregulations (1) and (2) shall not apply

to any airspace designated for military use.

Conversion of licence or rating issued by appropriate authority

- 65.01.3 (1) The holder of a licence or rating issued by an appropriate authority, who desires to obtain a licence or rating issued under this Part, shall apply to the Director in the appropriate form as prescribed in Document NA-CATS-ATSPL, for a conversion of such licence or rating.
- (2) The application for a conversion referred to in subregulation(1) shall be accompanied by -
 - (a) the appropriate fee as prescribed in Part 187;
 - (b) a certified true copy of the licence to which the conversion pertains;
 - (c) a valid medical certificate; and
 - (d) in the case of an application for the conversion of a licence or rating for the purpose of being employed as an air traffic service personnel member in Namibia, a temporary work permit or permanent residency permit and a letter of appointment from a Namibian employer who requires the services of the applicant.
- (3) A licence or rating issued by an appropriate authority may be recognised by the Director subject to the same restrictions which apply to such licence or rating and in accordance with and subject to the requirements and conditions

as prescribed in Document NA-CATS-ATSPL.

- (4) A licence or rating issued by an appropriate authority may be converted by the Director in the appropriate form as prescribed in Document NA-CATS-ATSPL.
- (5) The holder of a licence or rating issued by an appropriate authority and converted by the Director, shall at all times comply with the regulations in this Part and the requirements and conditions as prescribed in Document NA-CATS-ATSPL.

Medical fitness

- 65.01.4 An applicant for or holder of an air traffic service licence shall -
 - (a) in the case of an air traffic controller, obtain a Class 3 medical certificate; or
 - (b) in the case of an air traffic service assistant, obtain a Class 4 medical certificate,

issued in terms of Part 67.

Maximum hours of duty

ċ

65.01.5 The maximum hours of duty of air traffic service personnel for the purposes of aviation safety, shall be as prescribed in Document NA-CATS-ATSPL.

Ratings and certificates

65.01.6	(1)	The air traffic service ratings are -
	(a)	an air traffic service assistant rating;
	(b)	an air traffic service assistant (coordinator) rating;
	(c)	an air traffic service assistant (clearance delivery) rating;

Register of licences

- **65.01.7** (1) The Director shall maintain a register of all air traffic service licences issued or converted, ratings validated and certificates issued in terms of the regulations in this Part.
 - (2) The register shall contain the following particulars:
 - (a) The full name of the holder of the licence;
 - (b) the postal address of the holder of the licence;
 - (c) the date on which the licence was issued or converted;
 - (d) particulars of the ratings, validations and certificates held by the holder of the licence; and
 - (e) the nationality of the holder of the licence.

- (3) The particulars referred to in subregulation (2) shall be recorded in the register within seven days from the date on which the licence is issued or converted, or a rating is validated or a certificate is issued, by the Director.
- (4) The register shall be kept in a safe place at the office of the Director.
- (5) A copy of the register shall be furnished by the Director, on payment of the appropriate fee as prescribed in Part 187, to any person who requests the copy.

Language

65.01.8 Air traffic service personnel shall have sufficient ability in reading, speaking and understanding the English language to enable them to adequately carry out their responsibilities as air traffic service personnel.

Designation of validation examiners and rating assessment examiners

- **65.01.9** (1) The Director may designate -
 - (a) a validation examiner to conduct proficiency checks and to issue certificates of competency and temporary validation certificates;
 - (b) a rating assessment examiner to conduct proficiency checks and to issue certificates of competency and temporary rating certificates.

- (2) The privileges referred to in subregulation (1)(a) and (b) shall be exercised and performed according to the conditions, rules, requirements, procedures or standards as prescribed in Document NA-CATS-ATSPL.
- validation examiner or designated rating assessment examiner a document which shall state the full name of such validation examiner or rating assessment examiner and contain a statement that -
 - (a) such validation examiner or rating assessment examiner has been designated in terms of subregulation (1)(a) or (b), as the case may be; and
 - (b) such validation examiner or rating assessment examiner is empowered to exercise the privileges referred to in subregulation (1)(a) or (b), as the case may be.

Suspension and cancellation of licence and appeal

- (4) The holder of a licence, rating, validation or certificate who feels aggrieved by the suspension of the licence, rating, validation or certificate, may appeal against such suspension to the Director, within 30 days after such holder becomes aware of such suspension.
- (5) An appellant shall deliver an appeal in writing, stating the reasons why, in his or her opinion, the suspension should be varied or set aside.
- (6) The appellant shall submit a copy of the appeal and any documents or records supporting such appeal, to the air traffic service inspector concerned and shall furnish proof of such submission for the information of the Director.
- (7) The air traffic service inspector concerned may, within 30 days of receipt of the copy of the appeal referred to in subregulation (6), deliver his or her written reply to such appeal to the Director.
 - (8) The Director may -

i,

- (a) adjudicate the appeal on the basis of the documents submitted to him or her; or
- (b) order the appellant and the air traffic service inspector concerned to appear before him or her, either in person or through a representative, at a time and place determined by him or her, to give evidence.
- (9) The Director may confirm, vary or set aside the suspension referred to in subregulation (1).
 - (10) The Director shall -
 - (a) if he or she confirms the suspension in terms of subregulation(9); or
 - (b) if a licence, rating, validation or certificate is suspended in terms of subregulation (1) and the holder thereof does not appeal against such suspension in terms of subregulation (4),

cancel the licence, rating, validation or certificate concerned.

Air traffic service training organisation

65.01.11 Training as required by this Part shall only be provided by an air traffic service training organisation approved in terms of Part 141.

Consumption of alcohol and drugs

65.01.12 No air traffic service personnel member shall -

- (a) consume any liquor less than twelve hours prior to the specified reporting time for operational duty or the commencement of a shift;
- (b) commence an operational duty period while the concentration of alcohol in any specimen of blood taken from any part of his or her body is more than 0,00 gram per 100 millilitres;
- (c) consume alcohol during the operational duty period or whilston standby for operational duty;
- (d) commence an operational duty period while under the influence of liquor or any drug having a narcotic effect.
