In terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Permanent Secretary: Works, Transport and Communication proposes that, in the district of Gobabis the road described in the Schedule and shown on sketch-map P2022 by the symbols A-B be declared a proclaimed farm road (number 1692).
