SEA FISHERIES ACT, 1992 INCREASE OF TOTAL ALLOWABLE CATCH IN RESPECT OF HORSE MACKEREL AND PILCHARD

In terms of section 15 of the Sea Fisheries Act, 1992 (Act 29 of 1992), and after consultation with the Sea Fishery Advisory Council, I hereby determine that the Total Allowable Catch for the year 1998 determined by me in respect of horse mackerel and pilchard, and as specified in Government Notice No. 2 of 1998, shall be increased -

- (a) in the case of horse mackerel, from 300 000 metric ton to 375 000 metric ton; and
- (b) in the case of pilchard, from 40 000 metric ton to 65 000 metric ton.

DECLARATION OF KHORIXAS (EXTENSION 8) TO BE AN APPROVED TOWNSHIP

In terms of section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance No. 11 of 1963), I hereby declare the area situated on Portion 2 of the Farm Khorixas Townlands No. 884 in the Town Area of Khorixas, Registration Division A, and represented by the General Plan A132 (A315/96) to be an approved township.

The conditions, subject to which the application for permission to establish the township concerned has been granted, are set forth in the Schedule below in terms of the said section 13.

SCHEDULE

1. Name of township

The township shall be called Khorixas (Extension 8).

2. Composition of township

The township comprises 45 erven numbered 4106 to 4150 and streets as indicated on General Plan A132 (A315/96).

3. Reservation of erven

- (a) Erven 4110, 4117, 4124, 4135 and 4138 are reserved for the Town Council of Khorixas for the purposes of open spaces.
- (b) Erf 4106 is reserved for the State for general administrative purposes.

4. Conditions of title

- (1) The following conditions shall be registered in favour of the Town Council of Khorixas against the title deeds of all erven, except the erven referred to in paragraph 3.
 - "(a) There shall be no obstruction or deviation of any natural course of storm water over the erf without the written approval of the Town Council of Khorixas.
 - (b) The erf is subject to the reservation for the Town Council of Khorixas of the right of access to and use without compensation of an area three metres parallel with any boundary of the erf, for the construction and maintenance of council services in respect of water, sewerage, drainage, electricity and gas, which right includes the right to place on such erf temporarily any material that may be excavated or used during such operations on the erf or any adjacent erf.
 - (c) If the erf has more than one street frontage, access to the erf shall be obtained from the street determined by the Town Council of Khorixas.
 - (d) No offensive trade whatsoever shall be established or conducted on the erf.

For the purpose of this item, "offensive trade" means any of the businesses, trades, works or institutions mentioned in regulation 1(a) of the regulations promulgated under Government Notice No. 141 of 10 November 1926.

- (e) No cattle, pigs, goats, sheep, monkeys, beast of prey or draught animals shall be kept or allowed on the erf.".
- (2) The following conditions shall, in addition to those enumerated in subparagraph (1), be registered in favour of the Town Council of Khorixas against the title deeds of erven 4113 and 4123:
 - (a) The erf shall be used for flats and business purposes other than a factory as defined in section 3 of the Factories, Machinery and Building Work Ordinance, 1952 (Ordinance No. 34 of 1952): Provided that where a building is erected for business purposes the ground floor of the main building shall not contain flats and no flats shall be constructed on the same floor as any business or offices.
 - (b) The building value of a dwelling unit, including the outbuildings, to be erected on the erf shall be at least three times the prevailing valuation of the erf by the Town Council of Khorixas.".
- (3) The following conditions shall, in addition to those enumerated in subparagraph (1), be registered in favour of the Town Council of Khorixas against the title

deeds of erven 4107 to 4109, 4111, 4112, 4114 to 4116, 4118 to 4122, 4125 to 4134, 4136, 4137 and 4139 to 4150:

- "(a) The erf shall, except with the written approval of the Town Council of Khorixas, and subject to the provisions of item (c), be used for industrial purposes only.
 - "Industrial purposes" for the purposes of this item, means a factory as defined in section 3 of the Factories, Machinery and Building Works Ordinance, 1952 (Ordinance No. 34 of 1952).
- (b) The building value of the main building, including the outbuildings, to be erected upon the erf shall be at least two times the valuation of the erf by the Town Council of Khorixas, as at the date of the approval by the Town Council of the building plans relating to such buildings.
- (c) Notwithstanding the provisions of item (a), no tannery or abattoir of any kind shall, without the written consent of the Minister, be allowed or conducted on the erf.".
