PROPOSAL THAT A PORTION OF MAIN ROAD 44 BE CLOSED: DISTRICT OF SWAKOPMUND: ERONGO REGION

In terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Permanent Secretary: Works, Transport and Communication propose that, in the district of Swakopmund a portion of main road 44 described in Schedule I and in Schedule II by co-ordinates and shown by the symbols A-B-C-D-E-F, on sketch-map P2029 be closed.
