PROPOSAL THAT A PORTION OF MAIN ROAD 44 BE PROCLAIMED: DISTRICT OF SWAKOPMUND: ERONGO REGION

In terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Permanent Secretary: Works, Transport and Communication proposes that, in the district of Swakopmund a portion of main road 44 described in Schedule I and in Schedule II by co-ordinates and shown by the symbols A-B-C-D, on sketch-map P2030 be proclaimed.

A copy of this notice and the said sketch-map on which the road to which the proposal refers and other proclaimed, minor and private roads in the area are shown, shall for the full period of 30 days, mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Regional Engineer, Swakopmund, during normal office hours.

Every person having any objection to the above-mentioned proposal is hereby commanded to lodge his or her objection in writing, with the grounds upon which it is based clearly and specifically therein stated, with the Director: Planning and Transportation Management, Private Bag 12005, Ausspannplatz, within a period of 30 days from the date of publication of this notice.

SCHEDULE I

From a point (A on sketch-map P2030) at the junction with main road 52 on the common boundary of the farms Walvis Bay Town and Townlands No. 1 and Remainder of Portion B of Swakopmund Town and Townlands No. 41 generally northwards across the last-mentioned farm to a point (B on sketch-map P2030) at the junction with trunk road 2/2 on the last-mentioned farm; thence generally northwards and more and more north-north-westwards across the last-mentioned farm to a point (C on sketch-map P2030) on the last-mentioned farm; thence generally north-north-westwards across the last-mentioned farm, mining area Panther No. 36 B 18/57, Portion 21 of mining area Panther No. 36 B 18/57, Farm 134 and State Land to a point (D on sketch-map P2030) at the junction with main road 44 on the said State Land.

DECLARATION OF HENTIESBAAI (EXTENSION 8) TO BE AN APPROVED TOWNSHIP

In terms of section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance No. 11 of 1963), I hereby declare the area situated on Portion 52 of the farm Hentiesbaai Townlands No. 133 in the Municipal Area of Hentiesbaai, Registration Division G, and represented by General Plan G87(A492/95) to be an approved township.

The conditions, subject to which the application for permission to establish the Township concerned has been granted, are set forth in the Schedule below in terms of the said section 13.

SCHEDULE

1. Name of township

The township shall be called Hentiesbaai (Extension 8).

2. Composition of township

The township comprises 31 erven numbered 1896 to 1926 and streets as indicated on General Plan G87 (A492/95).

3. Conditions of title

ĸ,

- (1) The following conditions shall be registered in favour of the Municipal Council of Hentiesbaai against the title deeds of all erven:
 - "(a) There shall be no obstruction or deviation of any natural course of storm water over the erf without the written approval of the municipal council.
 - (b) The erf is subject to the reservation for the municipal council of a right of access and use without compensation of the area three metres parallel with any boundary of the erf, for the construction and maintenance of municipal services in respect of water, sewerage, drainage, electricity and gas, which right includes the right to place on the erf temporarily any material that may be excavated or used during such operation on the erf or any adjacent erf.
 - (c) If the erf has more than one street frontage, access to the erf shall be obtained from the street determined by the municipal council.
 - (d) No offensive trade whatsoever shall be established or conducted on the erf.

For the purpose of this paragraph, 'offensive trade' means any of the businesses, trades, works or institutions mentioned in regulation 1(a) of the regulations promulgated under Government Notice No. 141 of 10 November 1926.

- (e) No cattle, pigs, goats, sheep, monkeys, beast of prey or draught-animals shall be kept or allowed on the erf".
- (2) The following conditions shall, in addition to those enumerated in subparagraph (1), be registered in favour of the Municipal Council of Hentiesbaai against the title deeds of erven 1898 to 1926:

"The erf shall only be used for purposes of 'light industry' as defined in clause 1 of the Hentiesbaai Town Planning Scheme prepared and approved in terms of the Town Planning Ordinance, 1954 (Ordinance No. 18 of 1954)."

DETERMINATIONS UNDER THE BANKING INSTITUTIONS ACT, 1998 (ACT NO 2 OF 1998)

In my capacity as Governor of the Bank of Namibia (The Bank) and under the powers vested in the Bank by virtue of sections 71(3) of the Banking Institutions Act, 1998 (Act No 2 of 1998), read in conjunction with section 33 of the aforementioned Act, I hereby issue Determinations on Minimum Local Assets (BID-7), which Determinations shall become effective on 2 November 1998. These determinations shall supercede the Determinations on Minimum Local Assets (BID-7) published in the Government Gazette No. 1899 of 29 June 1998.

DETERMINATIONS ON MINIMUM LOCAL ASSETS

1. Minimum Local Assets to be Maintained

1.1 A banking institution shall at all times maintain minimum local assets situated in Namibia of an aggregate value not less than 100 per cent of the amount of its liabilities payable in Namibia Dollars (excluding capital funds) less any debit balances denominated in South African Rand (ZAR) in the clearing account held with its associate bank in South Africa.

2. Reporting

ĸ,

- 2.1 Every banking institution shall, within 21 days of the end of each calender month, complete and submit to the Bank the form annexed hereto and marked "Annexure A" BID-7.
- 2.2 In addition to paragraph 2.1 above, banking institutions are required to maintain a register where their daily balances shall be recorded regarding total liabilities payable in Namibia Dollars (excluding capital funds), debit balances held in clearing account with an associate bank in South Africa, and total local assets maintained by the banking institutions. The details of the register shall be used to support the average balances reported on the form annexed hereto and marked "Annexure A" BID-7. The register shall be made available for inspection and verification by the Bank.
- 2.3 In the event of the minimum local assets of a banking institution falling below the minimum requirement as determined in clause 1 thereof, this shall be reported in writing to the Bank within 2 working days of each

occurrence. Such report shall set out the reason(s) for non compliance and shall also state the expected duration thereof.

2.4 Nothing herein contained shall be construed to exclude the operation of Section 71(4)(b) of the Banking Institutions Act.
