It is hereby made known -

- (b) in terms of section 23(3) of the said Ordinance that the Minister has under section 23(1)(c) of the said Ordinance declared the road referred to in paragraph (a) to be a district road (number 3921).

PROPOSAL THAT ROADS BE DECLARED PROCLAIMED DISTRICT ROADS (NUMBERS 3636, 3637, 3638 AND 3639): DISTRICTS OF ONDANGWA, OSHAKATI AND EENHANA: REGIONS OF OSHANA AND OHANGWENA

In terms of section 20(1)(b) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is

hereby made known that the Permanent Secretary: Works, Transport and Communication proposes that, in the districts of Ondangwa, Oshakati and Eenhana, districts roads be proclaimed as described in Schedules I, II, III and IV and shown on sketch-map P2064 by the symbols A-B-C-D, E-F-F1-G-H, J-K-H-L1-M-M1-N and O-P-Q-R respectively.

A copy of this notice and the said sketch-map on which the roads to which the proposal refers and other proclaimed, minor and private roads in the area are shown, shall for the full period of 30 days, mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Roads Superintendent, Ondangwa, during normal office hours.

Every person having any objection to the above-mentioned proposal is hereby commanded to lodge his or her objection in writing, with the grounds upon which it is based clearly and specifically therein stated, with the Chairperson of the Roads Board, Private Bag 12005, Ausspannplatz, within a period of 30 days from the date of publication of this notice.

  - (i) N\$120-00 per annum if expected turnover of trade/business is less than N\$50 000 per annum.
  - (ii) N\$240-00 per annum if expected turnover of trade/business is more than N\$50 000 per annum.
  - (b) **Informal Trades or businesses**N\$10-00 per day per hawker, trader, peddler or vendor
  - (c) Home occupations N\$120-00 per annum

#### **Definitions**

1. In these regulations, unless the context otherwise indicates, a word or expression to which a meaning has been assigned in the Local Authorities Act, 1992 (Act 23 of 1992), shall bear that meaning, and -

"bees" means any breed of species of social bees belonging to the genera *Apis*, *Melipona* or *Trigonia* and forming part of the family Apidae and normally associated with the production of honey;

"Health Officer" means the head of the Health Department of the Municipality or any other official of the Municipality to whom the head has delegated any power, duty or function conferred or imposed on the head by these regulations;

"keep" means possess, control, supervise, or entrusted with;

"owners" in respect of bees, beehives, apparatus or equipment necessary for the keeping of bees, means a person who keeps such bees, beehives, apparatus or equipment;

"permit" means a permit to keep bees.

# Prohibition on keeping of bees

2. No person shall keep bees in the municipal area of Henties Bay without a permit.

### Requirements for keeping of bees

- 3. (1) A person who wants to keep bees shall have adequate knowledge and experience in the handling of bees, or employ another person with such knowledge and experience to keep the bees on such person's behalf.
- (2) the person referred to in subregulation (1) shall only keep the bees in a beehive which is constructed -
  - (a) of a rigid, weather resistant material other than metal; and
  - (b) in such a manner that -
    - (i) honeycombs are built in frames which are separated from each other and can easily be removed; and
    - (ii) the bees can at any time be partitioned off inside the beehive.
  - (3) A beehive referred to in subregulation (2), shall be -

- (a) placed at least 100 metres from any house, dwelling, business place or any place where animals, paultry or birds are kept in cages or enclosed areas;
- (b) kept on a premises of at least 1500 square metres; and
- (c) placed at a location that receives adequate shade and shelter; and surrounded by a strong wall or wire fence of at least 1,5 metres high and which is at no point nearer than 5 metres to any beehive, and such wall or fence shall be constructed -
  - (i) of material other than galvanized iron and in such a way that there is a gate at each gap in such fence which shall be locked at all times when the owner is not present at the beehive;
  - (ii) in such a manner that no person or animal shall be able to perform an act which may result in the bees concerned becoming annoyed and attacking any person or any animal, paultry or bird in a cage or enclosed area; and
  - (iii) in such a manner that no person or animal shall gain access to the beehive concerned.

# Application for permit

- **4.** (1) An application for a permit shall be made in the from of annexure A.
- (2) The applicant shall, after lodging the application with the Health Officer, at own expense cause an advertisement to be published once a week for two consecutive weeks in one or more local newspaper circulating in the municipal area -
  - (a) containing sufficient particulars of applicant;
  - (b) stating the applicant's intention to keep bees and the place where applicant intends to keep bees; and
  - (c) inviting persons who wishes to object to the keeping of bees by the applicant, to lodge those objections in writing with the grounds upon which they are based, with the Health Officer within 30 days from the date on which such advertisement last appeared.
- (3) The Health Officer shall, after having approved an application for a permit, issue such permit in the form of annexure B.
- (4) A permit issued under subregulation (3) is valid for a period of 12 months calendar and is renewable.
- (5) A permit holder may apply for the renewal of such holder's permit at least 30 days before the expiration of such permit, and such holder, when so applying, is not required to cause an advertisement referred to in subregulation (2), to be published.
- (6) A person who keeps bees at the date of publication of these regulations shall, within 30 days from that date, apply for a permit.
- (7) If the premises or beehives of the person referred to in subsection (6) do not meet the requirements of regulation 3, the Health Officer may grant a further period of 60 days in which such person may -
  - (a) improve the premises or beehives to meet such requirements; or
  - (b) find premises or beehives which meet such requirements.

### Occupation by bees

5. (1) If a swarm of bees occupies any object on any premises in order to

form a nest, the owner or occupier of such premises shall within 10 days of such occupation request the Health Officer to remove or destroy the bees.

(2) If the owner or occupier referred to in subsection (1) has not complied with that subregulation, such owner or occupier shall be deemed to having been keeping those bees without a permit.

# Objections to continuous keeping of bees by permit holder

- 6. (1) A person may lodge an objection with the Health Officer, to the continuous keeping of bees by a permit holder on any ground contemplated in regulation 8(c).
- (2) After the receipt of such objections referred to in subsection (1), the Health Officer may -
  - (a) reject the objection;
  - (b) order the permit holder to rectify any such situation as referred to in subsection (1), or
  - (c) cancel and rescind such permit in terms of regulation 8(c).

### Register

- 7. The Health Officer shall keep a register in which to record -
- (a) the name and address of a person applying for a permit;
- (b) the premises upon which a person keeps or will keep bees;
- (c) any objection raised against any application;
- (d) the name and address of every person who raised an objection;
- (e) the grounds on which an objection has been raised;
- (f) whether an application has been approved or not;
- (g) the date on which a permit was issued or cancelled; and
- (h) any particulars which the Health Officer may consider necessary.

#### **Powers of Health Officer**

- 8. The Health Officer may -
- (a) on application for a permit, refuse to issue a permit, issue a permit for a limited number of beehives which may be subjected to any condition the Health Officer may consider necessary;
- (b) at any time, before or after the issuing of a permit, inspect any land, premises, beehive, apparatus or equipment used in connection with the keeping of bees, to ascertain whether the applicant meets the requirements or the permit holder complies with these regulations;
- (c) after a 30 days written notice to the permit holder concerned, cancel a permit, if, the Health Officer is satisfied that -
  - (i) the permit holder contravenes or fails to comply with any regulation or condition under which a permit was issued;
  - (ii) the bees kept by the permit holder repeatedly causes a nuisance or disturbance to any person or animal or poultry or bird in a cage or

- enclosed area in the proximate vicinity of the place where the bees are kept;
- (iii) on a certificate issued by a registered medical practitioner the keeping of bees by the permit holder constitutes a health hazard to any person who lives, works or for any reason regularly visits, in the proximate vicinity of the place where the bees are kept;
- (d) order the owner who is not a permit holder, to remove or destroy such bees, beehives, apparatus or equipment within such period as the Health Officer may determine; or
- (e) if an owner fails to comply with an order issued under paragraph (d), remove the bees and beehives, or destroy the bees, beehives, apparatus and equipment.

# Appeal against decision of Health Officer

- 9. (1) An application for a permit may appeal against the decision -
- (a) disapproving the application for a permit; or
- (b) imposing an unreasonable limitation or condition on a permit.
- (2) A persons who raised an objection against the issue of a permit may appeal against the approval and issue of such permit.
- (3) A person who objected to the existing permit in terms or regulation 6, may appeal against the decision not to cancel and rescind such permit.
- (4) A permit holder may, upon receiving a notice in terms of regulation 8(c), appeal against the decision to cancel and rescind such holder's permit.
- (5) all the appeals under this regulation shall be lodged with the Management Committee.
- (6) A person who lodges an appeal under this regulation shall, within 14 days from the date on which the decision concerned has been made known to such person, or on which such person received the notice referred to in regulation 8(c), as the case may be, submit a full exposition of the grounds of appeal to the Management Committee.
  - (7) After the Management Committee has considered the appeal -
  - (a) it may confirm or dismiss the appeal;
  - (b) alter the decision; or
  - (c) remit the decision to the Health Officer for reconsideration.

#### Offences and penalties

- 10. (1) A person shall be guilty of an offence and liable on conviction to a fine not exceeding N\$1000 or to imprisonment for a period not exceeding three months, or to both, if such person -
  - (a) keeps bees without a permit or is deemed in terms of regulation 5 to keep bees without a permit;
  - (b) keeps bees and contravenes or fails to comply with regulation 3;
  - (c) makes any statement to the Health Officer regarding the keeping of or control over bees, beehives, apparatus or equipment necessary for the keeping of bees, which is false in any material respect, and knowing it to be false;

- (d) refuses or fails to answer any question put to such person by the Health Officer by virtue of a power conferred by these regulations;
- (e) fails or refuses to comply with a notice or order given or issued to such person in terms of these regulations; or
- (f) performs an act which is not authorized by these regulations and which may result in any bees becoming annoyed and stinging any person or any animal, poultry or bird in a cage or enclosed area.
- (2) Any person who is convicted for the second time for the same offence referred to in subsection (1), shall be liable, in addition to the penalties referred to in that subsection, to an administrative fine not exceeding N\$50 for each day the offence continues, and such fine shall be a debt due to the Municipality.

# REGULATIONS RELATING TO AMBULANCE SERVICES AND CHARGES

The Council of the Municipality of Windhoek, under section 94(1) and 30(1)(u) of the Local Authorities Act, 1992 (Act 23 of 1992) hereby makes the regulations and determine the charges as set out in the Schedule.

#### **SCHEDULE**

#### **Definitions**

- 1. In these regulations any word or expression to which a meaning has been assigned in the Local Authorities Act, 1992 (Act 23 of 1992) shall bear that meaning and unless the contract otherwise indicates -
- "Act" means the Local Authorities Act, 1992 (Act 23 of 1992) as amended;
- "advanced life support" means the assessment, treatment, administration intervention, monitoring and related functions of a patient falling within the ambit of practice of a registered critical care assistant contained in Schedule A annexed hereto;
- "ambulance charges" means the charges determine by the Council under section 30(1)(u) of the Act in respect of the rendering of Ambulance Services contained in Schedule B annexed to these regulations;
- "ambulance journey" means the period or distance of travelling of an ambulance from its point of departure at its base up to its arrival to the same base, or in the event of any interruption during the return journey to such base, up to such point in time and distance of such intervention;
- "ambulance service" means the Council's ambulance service as contemplated in section 30(1)(k)(ii) of the Act;
- "authorized official" means a person authorised by the Council;
- "basic life support" means the assessment, treatment, administration intervention, monitoring and related functions of a patient falling within the ambit of practice of a registered basic ambulance assistant contained in Schedule A annexed hereto;
- "intermediate life support" means the assessment, treatment, administration intervention, monitoring and related functions of a patient falling within the ambit of practice of a registered ambulance emergency assistant contained in Schedule A hereto;
- "patient" means any physically injured, mentally ill, or indisposed person and includes any deceased person so conveyed by the ambulance service;
- "urban areas" means that area within the municipal area of Windhoek surrounded by dwellings and other buildings on property within a proclaimed township in terms of the Townships and Division of Land Ordinance, 1963 (Ordinance 11 of 1963).

# Ambulance charges

- **2.** (1) Ambulance charges shall be payable to the Council for the conveyance of a patient by the ambulance service.
- (2) Ambulance charges shall be due and payble by the patient, or in the case of a minor, by his or her parents or legal guardian, or in the case of a deceased person, by his or her estate.

### **Billing of Ambulance Services**

- 3. (1) Billing of advanced life support and intermediate life support may only occur in the event of a registered critical care assistant and ambulance emergency assistant respectively, having examined, treated and/or monitored a patient while in transit to the hospital.
- (2) In the event of a critical care assistant or ambulance emergency assistant being present while a patient is conveyed to a hospital but does not render a service which falls within the ambit of the practice of such critical care assistant or ambulance emergency assistant respectively, the billing shall be based on that lower level of service rendered.

- (3) If the level of the service rendered by the ambulance service contemplated in (2) above, falls within the ambit of a basic ambulance assistant, the billing shall be based on the charges determined for basic life support.
- (4) Haemaccel and caloid solution excepted, the charges for each level of support shall be inclusive of any disposables other than pacing pads, heimlich valves, high capacity giving sets, dial a flow and intra-osseous needles and drugs used for the management of a patient as per Annexure "C" to these regulations.
- (5) Resuscitation fees may only be charged if the ambulance service has been accompanied by an ambulance in which event a critical care assistant or other authorized official shall motivate the reason for such resuscitation.
- (6) Each bill shall, as far as reasonably possible, contain the following information:
  - (i) Representative Association of Medical Scheme practice number;
  - (ii) name, telephone number and address of the ambulance service;
  - (iii) pre-authorization number;
  - (iv) the name of a medical fund member and its membership number;
  - (v) the name of the patient;
  - (vi) diagnosis of the patient's condition;
  - (vii) summary of medical procedures undertaken on a patient and vital signs of such patient;
  - (viii) summary of all equipment used;
  - (ix) the date on which the service was rendered.

- Endotracheal intubation (oral or nasal) with assisted ventilation
