# AMENDMENT OF ROAD TRAFFIC REGULATIONS: ROAD TRAFFIC ORDINANCE, 1967

The Minister of Works, Transport and Communication has under section 165 of the Road Traffic Ordinance, 1967 (Ordinance No. 30 of 1967) made the regulations set out in the Schedule.

#### **SCHEDULE**

1. In these regulations "the Regulations" means the Road Traffic Regulations promulgated under Government Notice No. 95 of 1967, as amended by Government Notices Nos. 88 of 1968, 97 and 123 of 1969, 130 of 1970, 176 of 1971, 51, 56, 58, 90, 144, 158 and 159 of 1972, 42, 124 and 164 of 1973, 30, 31, 135 and 238 of 1974, 1, 68,

87, 175, 214, 272, 310 and 341 of 1975, 214 and 400 of 1976, 61, 376 and 404 of 1977, 215 and 280 of 1978, 38 and 41 of 1979, AG. 131, AG. 137 and AG. 141 of 1981, AG. 8, AG. 9, AG. 151 and AG. 152 of 1982, AG. 123 and AG. 133 of 1983, AG. 2, AG. 56 and AG. 60 of 1984, AG. 78 of 1985, Government Notices Nos. 47 of 1990, 95 and 96 of 1992 and 102 of 1993, Act No. 1 of 1994, and Government Notices Nos. 190 of 1996, 42 of 1997, 20 of 1998 and 2 of 2000.

2. Regulation 15A. 1 of the Regulations is hereby amended by the insertion after the definition of "manufacturer" of the following definition:

"military combat vehicle" means a vehicle which is designed exclusively for military purposes;"

- **3.** Regulation 15A.4(1) is amended by the substitution for paragraph (f) of the following paragraph:
  - "(f)" that is a military combat vehicle of which the Ministry of Defence or the Ministry of Home Affairs is the title holder and owner;"
  - **4.** Regulation 15A.7 is amended by the insertion of subregulation (5):
    - "(5) If a registration certificate as required in subregulation (1)(d) with regard to a motor vehicle owned by the State does not exist, the appropriate registering authority must through a search of the Namibia Traffic System satisfy itself that the vehicle is not recorded as -
      - (a) being previously registered; or
      - (b) having been reported a stolen motor vehicle."

ROAD TRAFFIC ORDINANCE, 1967:
APPLICATION OF THE NAMIBIA TRAFFIC INFORMATION SYSTEM
(NaTIS) TO THE REGISTERING AUTHORITY AREA OF NAMIBIA
FOR THE REGISTRATION OF GOVERNMENT VEHICLES

Under section 55A(2) of the Road Traffic Ordinance, 1967 (Ordinance No. 30 of 1967), I hereby determine, in respect of motor vehicles of which the State is the owner, that-

- (a) the provisions of Chapter II of that Ordinance relating to the registration and licencing of motor vehicles shall not apply; and
- (b) the Namibia Traffic Information System (NaTIS) contemplated in section 55A(1) of that Ordinance shall apply, in respect of the whole of Namibia with effect from 1 April 2000.

Such motor vehicles shall be registered and licenced in accordance with the said NaTIS system during the periods as specified in the Schedule to this notice in respect of the different Government Ministries.

# ROAD TRAFFIC ORDINANCE, 1967: MOTOR VEHICLES OF GOVERNMENT, A REGIONAL COUNCIL AND A LOCAL AUTHORITY COUNCIL, SUBJECT TO THE PAYMENT OF MOTOR VEHICLE LICENCE FEES

In terms of regulation 15A.73 of the Road Traffic Regulations, 1967, Ordinance No. 30 of 1967, I hereby declare that motor vehicles, the owner of which -

- (a) is a Government Ministry, including an office or an agency, as defined in section 1 of the Public Service Act, 1995 (Act No. 13 of 1995) are subject to the payment of motor vehicle licence fees with effect from 1 April 2000; and
- (b) is a regional council or local authority council, are subject to the payment of motor vehicle licence fees with effect from 1 July 2000.

## ROAD TRAFFIC ORDINANCE, 1967 APPOINTMENT OF REGISTERING AUTHORITY FOR THE REGISTERING AUTHORITY AREA OF NAMIBIA FOR THE REGISTRATION OF GOVERNMENT VEHICLES

Under section 2(1) of the Road Traffic Ordinance, 1967 (Ordinance No. 30 of 1967), I appoint as registering authority in respect of motor vehicles of the Government of Namibia -

- (a) for the purpose of the registration and licencing of such vehicles, but excluding the issuing of temporary or special permits, the Ministry of Works, Transport and Communication; and
- (b) for the purpose of the issuing of temporary and special permits, the relevant registering authority appointed for the district concerned, other than the Ministry of Works, Transport and Communication referred to in paragraph (a).

## ROAD TRAFFIC ORDINANCE, 1967 COMPULSORY PRESENTATION FOR INSPECTION OF MOTOR VEHICLES OF WHICH THE OWNERS ARE GOVERNMENT MINISTRIES

Under section 55B of the Road Traffic Ordinance, 1967 (Ordinance No. 30 of 1967), I determine that a motor vehicle, owned by a Government Ministry, must be physically inspected on a date to be determined by a registering authority concerned, by -

- (a) a transport inspector or staff member of the Ministry of Works, Transport and Communication;
- (b) a traffic or police officer; or
- (c) any other person designated by the appropriate registering authority for the purpose.
