PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

- 1. The *Government Gazette* (Estates) containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, this *Government Gazette* is published on the preceding Thursday.
- 2. Advertisements for publication in the *Government Gazette* (Estates) must be addressed to the *Government Gazette* Office, P.B. 13302, Windhoek, or be delivered at Justitia Building, Independence Avenue, Second Floor, Room 219, Windhoek, not later than 15:00 on the ninth working day before the date of publication of this *Government Gazette* in which the advertisement is to be inserted.
- 3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.
- 4. Only legal advertisements shall be accepted for publication in the *Government Gazette* (Estates) and are subject to the approval of the Permanent Secretary, Ministry of Justice, who may refuse the acceptance of further publication of any advertisement.
- 5. The Ministry of Justice reserves the right to edit and revise copy and to delete there from any superfluous detail.
- 6. Advertisements must as far as possible be typewritten. The manuscript of advertisements must be written on one side of the paper only and all proper nouns plainly inscribed. - 1.5.5. authorised, in his discretion and depending on available resources, to make payments due in respect of claims made by members of the First Respondent;
- 1.5.6. directed to take custody of the cash, cash investments, stocks, shares and other securities held by the First Respondent, and of other property or effects belonging to or held by or on instructions of the First Respondent, or any entity, directly or indirectly controlled by, affiliated to or associated with the society;
- 1.5.7. authorised to conduct any investigation with a view to locating the assets belonging to the First Respondent, including such assets held by way of securities, in cash or liquid form, and for the purpose of the investigation the curator -
 - (a) shall have the powers conferred by section 4 of the Inspection of Financial Institutions Act, No. 38 of 1984, on an inspector appointed under that Act;
 - (b) may in addition to the said powers obtain the issue by the Registrar of this Court of any subpoena in order to obtain access to and possession of relevant documents, including records of banking accounts, from any person, if they have reason to believe that such documents may contain information relating to the investigation;
- 1.5.8. authorised to incur such reasonable expenses and costs as may be necessary or expedient for the curatorship and the control of the business and operations of the First Respondent, and to pay same from the assets held, administered or under the control of the society;

- 1.5.9. permitted to engage such assistance of a legal, accounting, administrative, or other professional or technical nature, as he may reasonably deem necessary for the performance of his duties in terms of this order and to defray reasonable charges and expenses thus incurred from the assets held or under control of the First Respondent;
- 1.5.10. authorised to institute or prosecute any legal proceedings on behalf of the First Respondent and to defend any litigation against the society;
- 1.5.11. authorised to invest such funds as are not required for the immediate purposes of the business, with a registered bank;
- 1.5.12. authorised to take control of and to operate or freeze existing banking accounts of the society and to open and operate any new banking accounts for the purposes of the curatorship;
- 1.5.13. vested with the discretionary power to decline any premature cancellations of membership by members of the First Respondent;
- 1.5.14. directed and authorised to apply, on notice to the Applicant, should he deems it necessary or expedient for an extension of his powers, and for instructions, from the Court in regard to any matter arising out of or in connection with the control and management of the business of the First Respondent;
- 1.5.15. authorised to claim, subject to Applicant's approval, all costs, charges and other expenditure reasonably incurred by the curator in the execution of his duties in terms of this order, including his own remuneration, as administration costs, in the event of the liquidation of the First Respondent ensuing; and

 - 1.6.2. to report to this Honourable Court on any irregularities committed by the First Respondent, Second Respondent, the management committee, or management or other officers and the contravention of any laws;

- 1.6.3. to recommend to this Honourable Court on the return day what further or alternative steps should be taken and by whom, in order to protect the interests of the members of the society and other creditors of the First Respondent;
- 1.6.4. to furnish the Applicant with progress reports on the curatorship on a fortnightly basis, and to file the report to the Court for the hearing on the return date, with a copy served on the Registrar's office, by no later than Monday, 20 August 2007;
- 1.7. The curator's remuneration is subject to the Applicant's approval, and is to be paid from the assets of, held by or under the control of the First Respondent on a preferential basis;
- 1.8. The costs of these proceedings, as between attorney and own client, the costs of the inspection conducted into the affairs of the society and the costs and remuneration of the curators, is to be paid by the Second Respondent, and
- 1.9. The costs of any opposition by any other party is to be paid by such party.
- Paragraphs 1.1 to 1.7 supra shall serve as an interim interdict with immediate effect pending the return date hereof.
- 3. This order shall as soon as possible be served on the respondents at First Respondent's principal place of business in Namibia and be published in abbreviated form as per annexure "A" in one issue of the *Government Gazette*, as well as the newspaper, The Namibian.
- 4. In the event of the Respondents or any interested party wishing to oppose the *rule nisi*, notice of such intention shall be given within 5 days from service, or publication, of this order and opposing affidavits, if any, shall be lodged with the Registrar of this Honourable Court and copies thereof served on the Applicant's attorneys, LorentzAngula, LA Chambers, Ausspann Plaza, Dr Agostinho Neto Road, Windhoek, Namibia (ref: Mr Ruben Philander) by no later than 12h00 Friday, 24 August 2007.
