DESCRIPTION OF GEOGRAPHICAL BOUNDARIES: !KHORO !GOREB CONSERVANCY SITUATED IN KUNENE REGION

The point of beginning is point 1, which is the most southern corner of the farm Navare 383. From this point the boundary moves to the north/east direction to point 2 southern corner of Waterval 384, from there it turn to northwestern direction to Navare Post to point 3, where it turns westerly up wards to the north/west boundary of the farm Waterfal 384 to point 4 and 5 on the north/east corner of the farm Waterfall 384. From point 5 it moves straight with slide turn south east to point 6, along the north boundary of farms Olifantshoek 388 and Renosterkop 389 and then south/east point 8 where it again moves down south to point 9 on the northern boundary of farm Lowenfontein 84. From this point it turns straight east to point 10 to the extreme eastern corner of farm Lowenfontein 84.

From this point the boundary moves more south-east along the Ugab River to point 11, southern boundary corner of farm Sebraskop 410. From this point it moves down to the southern direction via point 12 and moves up north-west and turn again south-west to point 13 south-east corner of Biesiesport 408, move up north to point 14 and up unit 15 with west boundary of Delta 400. From this point it moves west to point 16 north-east corner of Vaalhoek 397. The boundary move up north direction to join the southern boundary of Khorixa at point 17, from this point the boundary move straight east wards to the point of beginning which is the southern corner of the Navare 383. The portion of the air field strip is excluded as part of the conservancy.
