# AMENDMENT OF PERSONNEL RULES FOR THE MUNICIPALITY OF WALVIS BAY: LOCAL AUTHORITIES ACT, 1992

The Council of the Municipality of Walvis Bay, has under section 27(1)(c)(ii)(bb) of the Local Authorities Act, 1992 (Act No. 23 of 1992), with the approval of the Minister of Regional and Local Government and Housing and Rural Development, made the rules set out in the Schedule.

#### **SCHEDULE**

#### **Definition**

1. In these rules, "the Rules" means the Municipality of Walvis Bay, Personnel Rules published under Government Notice No. 310 of 18 October 1999.

#### **Substitution of rule 22 of the Rules**

**2.** The following rule is substituted for rule 22 of the Rules:

#### "22. VACATION BONUS

- (a) The Council must, annually and on a date determined by the Council, pay to an employee a vacation bonus at a rate of 8% percent of the employee's pensionable salary and pensionable allowances at the date of payment.
- (b) The vacation bonus contemplated in subrule (a) is calculated on a pro rata basis of the continuous service period worked by the employee but, excludes leave without remuneration taken by the employee in that period.
- (c) If an employee's contract of employment is terminated or an employee resigns, before the date of payment contemplated in subrule (a), that employee is entitled to a bonus referred to in that subrule calculated on a pro rata basis of the continuous service period worked by the employee, but excluding vacation leave without remuneration taken by the employee in that period.
- (d) The Council must pay, a vacation bonus referred to in subrule (-a) and calculated on a pro rata basis of continuous service period worked by the employee, since vacation bonus last accrued to employee -
  - (i) to an employee who retires on pension or whose service is terminated by the Council for reasons of ill-health or on account of the retrenchment of employee or the abolition of his or her post; or
  - (ii) to the next of kin or estate of an employee who has passed away.".
