PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

ORDER

Having heard Ms Kazondunge Counsel for the Applicant and having read the Notice of Motion, Affidavits and annexures thereto and other documents filed of record;

IT IS HEREBY ORDERED THAT:

- A rule nisi is hereby issued calling upon Fort Nox Distribution CC and Georgetown Investment CC to show cause, if any on 15 August 2014 at 10:00 am why an order in the following terms should not be made final:
 - 1.1. That a preservation of property order, as contemplated by Section 51 of the Prevention of Organized Crime Act, Act No. 29 of 2004 (POCA) is granted in respect of the positive balance in First National Bank, SME Cheque account number: 62250421246 held in the name of Fort Nox Distribution CC and the positive balance in First National Bank, SME Cheque account number: 62250422129 held in the name of Georgetown Investment CC.
 - 1.2. That in terms of section 51 of POCA all persons with knowledge of this order, other than as required and permitted by this order, are prohibited from removing, and or taking possession of and/or control over, and/or dissipating, and/or interfering with, and/or diminishing the value of, and/or attaching or selling in execution, and/or dealing in any other manner with any of the properties to which this order relates.
 - 1.3. That Warrant Officer John Nico Green ("Warrant Green") of the Commercial Crime Unit: Anti Money Laundering and Asset Forfeiture Division at Windhoek or, in Warrant Green's absence, the Head of the Commercial Crime Unit: Anti Money Laundering and Asset Forfeiture Division in Windhoek, is appointed as Curator Bonis in terms of section 55 of POCA and is immediately authorized to:
 - 1.4. Seize and or assume control over the properties;
 - 1.4.1. Safeguard the properties pending the finalization of the forfeiture proceedings under POCA;
 - 1.4.2. If necessary to administer and preserve the properties and to do all things necessary for that purpose, including keeping the money in the bank accounts where it is currently kept subject to appropriate safeguards and/or withdraw the money from the accounts and deposit same in a different interest bearing account;
 - 1.5. The Applicant must effect service of the final preservation of property order on:

- 1.5.1. Fort Nox Distribution CC and;
- 1.5.2. Georgetown Investment CC by publication of the preservation of property order in two daily newspapers of wide circulation as provided for by regulation 3 (1) (b) of POCA regulations.
- 1.6. In terms of section 52 (1) (b) cause notice of this order, in the form set out in Annexure B hereto, to be published in the Government Gazette as soon as practicable after the order is granted.
- 1.7. Any person who has an interest in the properties and who intends opposing the application for an order forfeiting the properties to the State or applying for an order excluding his or her interest from a forfeiture order in respect of the properties, must enter an appearance giving notice of his or her intention in terms of section 52 (3) of POCA.
- 1.8. Such notice must be delivered to the Applicant:
 - 1.8.1. in the case of any person specifically identified for service in terms of this order, within 21 calendar days of service; and
 - 1.8.2. in the case of any other person, within 21 calendar days after the date when a notice of the order was published in the Government Gazette.
- 1.9. A notice in terms of section 52 of POCA must contain full particulars of the chosen address for the delivery of documents concerning further proceedings in this matter and must be accompanied by an affidavit setting out:
 - 1.9.1. the full particulars of the identity of the person giving the notice;
 - 1.9.2. the nature and extent of his or her interest in the properties concerned;
 - 1.9.3. whether he or she intends opposing the making of the forfeiture order, or whether he or she intends applying for an order excluding his or her interest in the properties from the operation of the order;
 - 1.9.4. whether he or she admits or denies that the property concerned is an instrumentality of an offence referred to in schedule 1 of POCA, or is the proceeds of unlawful activities and the basis for such defense;
 - 1.9.5. if he or she intends applying for the exclusion of his or her interests from the operation of the forfeiture order, the basis for such an application.
- 2. Paragraphs 1.1 to 1.4 supra are to operate as an interim order with immediate effect pending the return date of the *rule nisi*.
- 3. The Applicant is also granted leave to effect service of this order by publication in two daily newspapers of wide circulation as provided for by regulation 3 (1) (b) of POCA regulations, calling upon Fort Nox Distribution CC and

Georgetown Investment CC to file a notice in opposition of the confirmation of the preservation of property order within 5 days of publication of the order.
