PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

- 3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.

IT IS HEREBY ORDERED THAT:

- 1. The applicant's non compliance with the Rules of this Honourable Court relating to service and time periods is condoned and the matter is heard on an urgent basis.
- The prescribed manner for applications of this nature as set out in the regulations to the Prevention of Organised Crime Act 29 of 2004 ("POCA") as well as any other manner prescribed in POCA is dispensed with.
- A preservation of property order as contemplated by section 51 of POCA is granted in respect of the positive balance in First National Bank account number 62251053212 held in the name of James B Wallace, the positive balance in First National Bank account number 62256727185 held in the name of Zhi Geng, the positive balance in Bank Windhoek account number 8004949700 held in the name of Zhi Geng and the positive balance in Standard Bank account number 247508950 held in the name of Zhi Geng; a Nissan with Natis register number RVH382H; a Nissan Terrano with Natis register number RWB426H; a Honda with Natis register number RZL550H and registration number N151460W; a Mitsubishi Pajero with Natis register number SBG652H; a Landrover Discovery with Natis register number SCS037H; a Volkswagen Passat with Natis register number SDGOO6H and registration number N88503W. ("the properties").
- 4. In terms of section 51 of POCA all persons with knowledge of this order, other than as required and permitted by

- this order, are prohibited from removing, and or taking possession of and / or control over, and / or dissipating, and / or encumbering and / or interfering with, and / or diminishing the value of, and / or attaching or selling in execution, and / or dealing in any other manner with the properties to which this order relates.
- 5. Warrant Officer Emilia Nambadi ("Warrant Nambadi") of the Commercial Crime Investigation Unit: Anti ó Money laundering Sub ó Division in Windhoek or, in Warrant Nambadi's absence, Warrant Officer Johan Nico Green ("Warrant Green") of the Commercial Crime Investigation Unit: Anti ó Money laundering Sub ó Division in Windhoek, is appointed as Curator Bonis in terms of section 55 of POCA and is immediately authorized to:
 - 5.1 Seize and or assume control over the properties;
 - 5.2 Safeguard the properties pending the finalization of the forfeiture proceedings under POCA;
 - 5.3 If necessary to administer and preserve the properties and to do all things necessary for that purpose, including keeping the money in the bank account where it's currently kept subject to appropriate safeguards and / or deposit the money in the account into a separate interest bearing account.
