PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

IT IS HEREBY ORDERED THAT:

Warrant Officer, Emilia Nambadi ("Warrant Nambadi") of the Commercial Crime Investigation Unit: Asset Forfeiture Unit in Windhoek or, in Warrant Nambadi absence, Warrant Officer Johan Nico Green ("Warrant Green") of the Commercial Crime Investigation Unit: Asset Forfeiture Unit in Windhoek, is appointed to take care of the properties in terms of section 55 read with section 93 of POCA and is immediately authorized to:
 - 3.1 Seize and or assume control over the properties;
 - 3.2 Safeguard the properties pending the finalization of the forfeiture proceedings under POCA;
