PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

3. A *rule nisi* is hereby issued calling upon the Respondent and all/any interested parties to show cause (if any) on/ before the **30th day of OCTOBER 2020 at 10H00**, why:
 - 3.1 the Respondent should not be placed under final order of liquidation;
 - 3.2 the costs of this application should not be costs in the winding-up of the Respondent.
4. Service of this order shall be effected;
 - 4.1 on the Respondent by the Deputy-Sheriff, by delivering a copy thereof at the Respondent's registered address being Unit No. 2, Reger Park, Reger Street, Windhoek, by the Deputy-Sheriff for Windhoek; and
