PUBLICATION OF ORDINANCE OF LEGISLATIVE ASSEMBLY OF THE WHITES

Die volgende Ordonnansie waartoe die Administrateur-generaal ingevolge die bepalings van die Proklamasie op Verteenwoordigende Owerhede, 1980 (Proklamasie AG. 8 van 1980), toegestem het, word hierby ingevolge artikel 16 van die Proklamasie op die Verteenwoordigende Owerheid van die Blankes, 1980 (Proklamasie AG. 12 van 1980), afgekondig:-

**DELEGATION OF POWERS AMENDMENT
ORDINANCE, 1982.**

**Ordinance
No. 3 of 1982**

ORDINANCE

To amend the Delegation of Powers Ordinance, 1973, so as to adjust certain definitions and the designation of Secretary for South West Africa to changed circumstances; to abolish the provision for delegation to a member of the Executive Committee; and to provide for incidental matters.

BE IT ORDAINED by the Legislative Assembly of the Whites as follows:-

1. Section 1 of the Delegation of Powers Ordinance, 1973 (hereinafter referred to as the principal Ordinance), is hereby amended —

Amendment of section 1 of Ordinance 24 of 1973, as amended by section 1 of Ordinance 20 of 1975.

(a) by the substitution for the definition of "Executive Committee" of the following definition:

"'Executive Committee' means the Executive Committee of the Whites;"; and

(b) by the substitution for the definition of "official" of the following definition:

"'official' means any person in or seconded to the service of the Representative Authority of the Whites.".

2. Section 2 of the principal Ordinance is hereby amended —

Amendment of section 2 of Ordinance 24 of 1973.

(a) by the substitution for paragraph (a) of the following paragraph:

"(a) the Secretary of the Administration for Whites; or";

(b) by the substitution for paragraph (b) of the following paragraph:

"(b) any other official."; and

(c) by the deletion of paragraph (c).

3. The following long title is hereby substituted for the long title of the principal Ordinance:

Substitution of long title of Ordinance 24 of 1973.

“To empower the Executive Committee of the Whites and officials of the Representative Authority of the Whites to delegate certain powers, authorities and functions; and to provide for incidental matters.”.

4. This Ordinance shall be called the Delegation of Powers Amendment Ordinance, 1982.
