ACT

To amend the Road Traffic Ordinance, 1967, so as to increase the motor vehicle licence fees; and to provide for incidental matters.

(Signed by the President on 19 December 1995)

BE IT ENACTED by the Parliament of the Republic of Namibia, as follows:-

Provided that in respect of a motor vehicle (other than a tractor, truck-tractor or self-propelled caravan) not designed principally for the conveyance on a public road of persons or goods, or both, which is operated on a public road, the licence fee shall not exceed N\$171,00."

Short title and commencement

2. This Act shall be called the Road Traffic Amendment Act, 1995, and shall come into operation on 1 January 1996.
