### ACT

# To appropriate amounts of money to meet the financial requirements of the State during the financial year ending 31 March 1997.

(Signed by the President on 29 May 1996)

**BE IT ENACTED** by the Parliament of the Republic of Namibia, as follows:-

#### Appropriation of amounts of money for financial requirements of State.

1. Subject to the provisions of the State Finance Act, 1991 (Act 31 of 1991), there are hereby appropriated for the financial requirements of the State during the financial year ending 31 March 1997, as a charge to the State Revenue Fund, the amounts of money shown in the Schedule.
