PROMULGATION OF ACT OF PARLIAMENT

The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

Act No. 16, 2002

ADDITIONAL APPROPRIATION ACT, 2002

ACT

To appropriate supplementary amounts of money to meet additional financial requirements of the State during the financial year ending 31 March 2003.

(Signed of the President on 23 December 2002)

BE IT ENACTED by the Parliament of the Republic of Namibia as follows:

Appropriation of amounts of money for financial requirements of the State

1. Subject to the State Finance Act, 1991 (Act 31 of 1991), the amounts of money shown in the Schedule are appropriated as a charge to the State Revenue Fund for additional financial requirements of the State during the financial year ending 31 March 2003.

Short title

2. This Act is called the Additional Appropriation Act, 2002
