### ADDITIONAL APPROPRIATION ACT, 2003

### **ACT**

To appropriate supplementary amounts of money to meet additional financial requirements of the State during the financial year ending 31 March 2004.

(Signed by the President on 21 December 2003)

BE IT ENACTED by the Parliament of the Republic of Namibia as follows:

### Appropriation of amounts of money for financial requirements of the State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated as a charge to the State Revenue Fund for additional financial requirements of the State during the financial year ending 31 March 2004.

#### **Short title**

2. This Act is called the Additional Appropriation Act, 2003.
