ANNOUNCEMENT OF APPOINTMENTS OF ACTING JUDGES FOR THE SUPREME COURT AND HIGH COURT: ARTICLE 32 (4)(a) OF THE NAMIBIAN CONSTITUTION

In terms of Sub-article (8) of Article 32 of the Namibian Constitution, I announce that I have under the powers vested in me by Sub-article (4)(a)(aa) of that Article, and on the recommendation of the Judicial Commission, appointed as Acting Judges -

- (a) in terms of sub-article (2) of Article 82 of the Constitution, to the Supreme Court, the persons whose names appear in the first column of Schedule 1, for the duration as indicated in the second column of that Schedule; and
- (b) in terms of sub-article (3) of Article 82 of the Constitution, to the High Court, the persons whose names appear in the first column of Schedule 2, for the duration as indicated in the second column of that Schedule.
